- 1. FULL CHARGE FOR BASIC STORAGE IS DUE AND PAYABLE UPON APPLICATION.
2. DUE TO INSURANCE REGULATIONS, ONLY NAVESINK MARINA PERSONNEL WILL PERFORM EXTERIOR MAINTENANCE OF ANY KIND BELOW THE GUNWALE.
3. Any condition aboard or around a boat declared a fire hazard, in the judgment of Navesink Marina, shall be removed by the owner to the satisfaction of Navesink Marina.
4. Wet Storage charges include storage in water with bubble system; haul out during spring commission period, but no other services.
5. Berthing spaces are assigned to the holder of a permit for a particular boat.
6. All boats occupying berths shall be equipped with proper lines approved by Navesink Marina.
7. The vessel covered by this storage contract must be removed from Navesink Marina upon expiration of contract.
8. The owner agrees that all charges accruing under the terms of this agreement shall constitute a valid lien upon the boat, and Navesink Marina may retain possession of said boat until all charges are fully paid, or upon the (10) days notice to the owner, may proceed with said ACTION AS MAY BE NECESSARY TO ENFORCE PAYMENT OF ALL CHARGES DUE.
9. All boats offered for sale or sold while at Navesink Marina facility must be listed and sold through Navesink Marina or its designate.
10. All unpaid invoices (both storage and service invoices) more than 30 days past due will be subject to a Finance Charge of 1 1/2% per month which is an 18% annual rate.
11. The granting of winter storage hereunder is with a distinct understanding, and the applicant hereby agrees, that Navesink Marina assumes no responsibility whatsoever, and is not liable for, personal injuries sustained by the applicant or any of the applicant's guests on any part of the Marina property and assumes no responsibility, and is not liable for the safety of any vessel stored, wet or dry, at the Marina, and will not be liable for fire theft, ice damage or damages to said vessel, its equipment, or any property in or on said vessel on Marina property, however arising, reserving to Navesink Marina the right to assume control and charge of any vessel for the protection of life and property under abnormal conditions or during catastrophes. No insurance of any kind is carried by Navesink Marina on boats or their equipment.
